# School Library Snapshot



## **IMC Space**

Our district houses two separate libraries. One is in the elementary and one is shared between middle school/high school.



# Library Lessons and Classroom Support

Library staff teaches 792 lessons a year in the elementary. We also support teachers of ELA and STEM across the building.



### **Books**

Between both libraries, over 10,000 items are circulated annually.



# Digital Citizenship

In 2022, weekly digital citizenship lessons were added to grades 2-5. Keyboarding is also taught during this time.



### **Devices**

1,006 devices are checked out, serviced and managed by our school libraries and technology department.



# **Staff**

The libraries are staffed by 3 FTE employees: a licensed media specialist and 2 paraprofessionals


# Current Status: Curriculum, Instruction & Assessment

### **Subscriptions**

The library program purchases annual subscriptions to online resources with ebooks, video streaming, and reference databases.

### **Instructional Partners/Student Creation**

- -Promote reading and lifelong learning through library programming. We also host 2 Book Fairs a year to encourage reading at home.
- -Provide support for research projects by curating resource lists for teachers, assisting students with item location, and offering lessons and support on the technology side for class projects.
- -Assist ELA and STEM teachers with resource curation including reading selections and technology equipment such as 3D printers, Osmo Kits, and Robotics
- -Facilitate collaborative learning within the IMC space. In 2023, we converted our chromebook lab into a MAC Studio with a Podcasting station.



# Current Status: Personalized Professional Learning

### Staff:

- -Surveyed staff in the Spring of 2023 to gain input on what professional development they are interested in and the format they would most like it offered in.
- -District Media Specialist offers annual Professional Development on Google Classroom and Library Resources for new staff at new teacher orientation and refreshers during back to school inservice. If more assistance is needed or other topics need coverage, we move on to staff meeting presentations and peer coaching.
- -District Media Specialist serves on building both building level teams known as BLTS, the technology planning team, and the district level team known as the DLT to gain insight on building and district needs and also offer suggestions for professional learning.



# Current Status: Robust Infrastructure

### **User Accounts:**

Accounts more secure this year with the Clever Badge login for K-3 and Microsoft Azure logins for 4-12 and staff

### 1:1 Chromebooks:

All students K-12 have an individual device provided by the district. These devices are circulated and serviced via the school libraries.



# Current Status: Budget and Resources

### **Budget:**

Utilizing Common School Funds to strategically improve our library collections and resources available. This is based on school and community needs.

### Resources:

Analyzing online database usage reports to determine value of renewing subscriptions.

Support STEM and Fab Lab programs with technology purchases.



# Current Status: Community Partnerships

### -Forest County Potawatomi

Working with FCP Cultural Center and Library to improve overall library collection to be more culturally sensitive. FCP staff serves as a resource for book reviews and will hopefully help us source some items not available through mainstream vendors.

IMC space is used to house FCP tutoring or other community partners meeting with students.

#### -Rural Virtual Academy

RVA utilizes our space as a learning center for virtual students in need of a place to study or access the internet. IMC aide also is the assigned staff member to set-up courses and offer technical support.

#### -Nicolet College

IMC space is used all hours of the day as a room assignment for students taking college courses through Nicolet

### -Forest County Public Libraries

District Media Specialist serves on the Forest County Board of Trustees, which governs the county portion of the budgets for all public libraries in the county.



# Current Status: Data and Privacy

- -Utilize FollowMe printing to ensure privacy with library records printed
- -Subscription Evaluation ensuring student data is secure
- -Teach Common Sense Digital Citizenship curriculum to grades 2 to 5. Lesson topics include internet safety, privacy, media balance, and cyberbullying.
- -Prioritize purchasing digital resources that have Multi-Factor Authentication for users


